



## Free Breakfast and Lunch for All Students in Milton Schools!

Dear Parent or Guardian:

Great news for you and your children! All students attending *Milton Elementary, H.O. Brittingham and Mariner Middle* can continue to get a healthy breakfast and lunch at school for **FREE** in the 2017-18 school year.

What do you have to do?

- You do not need to do anything. **Siblings attending Cape High, Lewes School, Beacon Middle, Richard Shields and Rehoboth Elementary**, will have to fill out and submit a meal benefit form for the 2017-18 school year or pay for their meals.
- You do not have to pay any money (for breakfast or lunch meals) or fill out any forms.

*Milton Elementary, H.O. Brittingham and Mariner Middle* schools will be getting free meals for all students as part of the National School Lunch Program (NSLP) and School Breakfast Program (SBP) through a choice for schools called the Community Eligibility Provision (CEP).

### Community Eligibility Provision (CEP) 2017-18

The Community Eligibility Provision (CEP) for the National School Lunch Program (NSLP) and School Breakfast Program (SBP) gives Cape Henlopen Schools with high percentages of low-income children the option to offer free school meals to all children in those schools without collecting applications at these schools. Under this provision, the Cape District has elected to provide free meals to all students at the schools listed below and is reimbursed by the federal government:

***Milton Elementary  
H.O. Brittingham Elementary  
Mariner Middle***

Note:

- Extra a-la-carte items will be charged accordingly.
- Meals not having enough required components will be charged a-la-carte pricing.
- To receive meal benefits at Cape High, Lewes School, Beacon Middle, Richard Shields and Rehoboth Elementary, an approved meal benefit form must be filled out and submitted for the 2017-18 school year.
