<u>Full Description</u>: Frozen California Blend is prepared from a combination of broccoli, cauliflower and carrots that have been prepared from clean, sound, succulent vegetables by trimming, washing, sorting and properly draining. The product is blanched for enzyme inactivation, individually quick-frozen, and maintained at temperatures necessary for its preservation.
