<u>Full Description</u>: Frozen Italian Blend Vegetables are prepared from zucchini, cauliflower, carrots, Italian beans, lima beans and red peppers in the required proportions by trimming, washing, sorting and properly draining. The product is blanched for enzyme inactivation, individually quick-frozen, and maintained at temperatures necessary for its preservation.

Defects	Must be practically free from EVM, blemishes and seriously blemished pieces, mechanical damage, loose scale, undeveloped seeds, core and stem material, and trimming.

Physical Characteristics:

Seneca Foods Corporation produces our products to meet a target specification at the time of production. Due to the nature of our commodity products, there are factors such as product maturity, variety, moisture level, and the growing conditions of each particular field which may cause a deviation from the target specification as the product cycles through the shelf life.
