Full Description: Frozen Cooked Squash is prepared from clean, sound, properly matured, varieties of the fall or late type squash, by washing, stemming, cutting, removing seeds and fiber, reducing to a pulp and cooking to inactivate enzymes. The product is quickly cooled, packed and frozen in accordance with the best quick-freezing practices and maintained at temperatures necessary for its preservation.

Quality Characteristics:

Quality	Must meet USDA Grade A as required. Must comply with the US Standard for Grades of Frozen Cooked Squash, with modifications noted within these specifications.
Flavor and Odor	After heating, product has a good characteristic normal flavor and odor and is free from objectionable flavors and odors of any kind.
Color	Yellow to tan color that is practically uniform, bright, and typical of the variety and is free from discoloration due to oxidation or other causes.
Consistency	Has a good consistency; which means, the warmed mixed squash, after emptying the container onto a dry surface forms a well-rounded mass and that at the end of two minutes after emptying there is not more than a slight separation of free liquor.
Defects	Practically free from defects – contains no grit, sand or silt that would affect the eating quality or appearance. Any defects present, individually or collectively do not more than slightly affect the appearance or eating quality of the product.

Physical Characteristics:

Seneca Foods Corporation produces our products to meet a target specification at the time of production. Due to the nature of our commodity products, there are factors such as product maturity, variety, moisture level, and the growing conditions of each particular field which may cause a deviation from the target specification as the product cycles through the shelf life.
