

MEAL CHARGING POLICY
LAKE TAHOE UNIFIED SCHOOL DISTRICT FOOD DEPARTMENT

CHARGING POLICY: A STUDENT IS ALLOWED TO CHARGE A MAXIMUM OF TWO (2) MEALS (\$6.50 MAXIMUM AT HIGH SCHOOL; \$6.00 MAXIMUM AT MIDDLE SCHOOL; \$5.00 MAXIMUM AT ELEMENTARY SCHOOLS). AFTER ONE (1) MEAL CHARGE, A PHONE CALL WILL BE MADE TO THE PARENT/GUARDIAN BY THE CAFETERIA SUPERVISOR OR THE CAFETERIA ASSISTANT. IF A STUDENT'S ACCOUNT IS IN ARREARS MORE THAN THE EQUIVALENT OF TWO (2) MEALS, THE STUDENT'S BREAKFAST OR LUNCH WILL BE SUBSTITUTED UNTIL THE ACCOUNT IS PAID IN FULL. THE SUBSTITUTED MEAL WILL CONSIST OF A COMPLIMENTARY BREAKFAST CONSISTING OF 1 SLICE OF WHEAT BREAD WITH SUNFLOWER BUTTER OR CHEESE AND A CARTON OF WHITE MILK OR A COMPLIMENTARY LUNCH CONSISTING OF 2 SLICES OF WHEAT BREAD WITH SUNFLOWER BUTTER OR CHEESE AND A CARTON OF WHITE MILK. THE CAFETERIA SUPERVISOR WILL CONTACT THE PARENT/GUARDIAN TO RESOLVE THE SITUATION AS SOON AS POSSIBLE. IF A CASE OF EMERGENCY OR EXTREME NEED IS DETERMINED, THE SITE PRINCIPAL WILL BE ASKED TO ASSIST IN THE MATTER ALONG WITH THE DIRECTOR OF SCHOOL NUTRITION.
