DISTRICT WELLNESS

The district recognizes that student wellness and proper nutrition are related to students' physical well-being, growth, development, and readiness to learn. The district is committed to providing a school environment that promotes student wellness, proper nutrition, nutrition education, and regular and physical activity as part of the total learning experience. In a healthy school environment, students will learn about and participate in positive dietary and lifestyle practices.

Food and Beverage Availability

The district is committed to serving healthy meals to students, with plenty of fruits, vegetables, whole grains, and fat-free and low-fat milk; that are moderate in sodium, low in saturated fat, and have zero grams trans fat per serving (nutrition label or manufacturer's specification); and to meeting the nutrition needs of school children within their calorie requirements. The school meal programs aim to improve the diet and health of school children, help mitigate childhood obesity, model healthy eating to support the development of lifelong healthy eating patterns, and support healthy choices while accommodating cultural food preferences and special dietary needs.

All schools within the district participate in USDA child nutrition programs through the National School Lunch Program (NSLP) and the School Breakfast Program (SBP) and are committed to offering school meals that:

- are accessible to all students
- are appealing and attractive to children
- are served in clean and pleasant settings
- meet or exceed current nutrition requirements established by local, state, and federal statutes and regulations
- promote healthy food and beverage choices using Smarter Lunchroom techniques as recommended by the USDA where appropriate

Students in grades Pre-K to fifth grade will be provided a minimum of 20 minutes to consume lunch after they have received their food.

Schools will not use foods or beverages as rewards for academic performance or good behavior. Additionally, schools will not withhold food or beverages as punishment. Teachers are provided with a list of alternative ideas for behavior management.

Water

To promote hydration, free, safe, unflavored drinking water will be available to all students throughout the school day and throughout every school campus. The district will make drinking water available where school meals are served during mealtimes.

Competitive foods and beverages

The district is committed to ensuring that all foods and beverages available to students on school campuses during the school day support healthy eating. The foods and beverages sold outside of the school meal programs (e.g., "competitive" foods and beverages) will meet the USDA Smart Snacks in School nutrition standards, at a minimum. See administrative rule EFE-R, Competitive Foods Sales/Vending Machines, for more information. The district will establish standards for foods made available, but not sold, during the school day on school campuses.

All foods that meet the competitive food standards may be sold at fundraisers on the school campus during school hours. The number of fundraisers exempt from the nutrition requirements will be determined by the South Carolina State Board of Education (see administrative rule EFE-R).

District Goals for Health and Wellness

Nutrition promotion

Nutrition promotion and education positively influence lifelong eating behaviors by using evidence-based techniques and nutrition messages and by creating food environments that encourage healthy nutrition choices and encourage participation in school meal programs. Students and staff will receive consistent nutrition messages throughout schools, classrooms, gymnasiums, and cafeterias. Nutrition promotion also includes marketing and advertising nutritious foods and beverages to students and is most effective when implemented consistently through a comprehensive and multi-channel approach by school staff, teachers, parents/legal guardians, students, and the community.

The district will promote healthy food and beverage choices for all students throughout the school campus and will encourage participation in school meal programs. This promotion will occur through the use of evidence-based healthy food promotion techniques through the school meal programs using Smarter Lunchroom techniques and through adherence to a policy of 100% of foods and beverages promoted to students meeting the USDA Smart Snacks in School nutrition standards.

Nutrition education

The district will teach, model, encourage, and support healthy eating by all students. Schools will provide nutrition education and engage in nutrition promotion that fulfills the following criteria:

- fosters the adoption and maintenance of healthy eating behaviors such as acquiring skills for reading food labels and menu planning
- is part of a sequential comprehensive standards-based health education program designed to provide students with the knowledge and skills necessary to promote and protect their health
- promotes fruits, vegetables, whole-grain products, low-fat and fat-free dairy products, and healthy food preparation methods
- emphasizes caloric balance between food intake and energy expenditure (promotes physical activity/exercise)
- links with school meal programs, cafeteria nutrition promotion activities, school gardens, Farm to School programs, and other school foods and nutrition-related community services
- teaches media literacy with an emphasis on food and beverage marketing
- includes nutrition education training for teachers and other staff

Physical activity

Children and adolescents should participate in at least 60 minutes of physical activity every day. A substantial percentage of students' physical activity can be provided through a comprehensive school physical activity program which includes quality physical education as the foundation; physical activity before, during, and after school; staff involvement; and family and community engagement. Schools may promote opportunities for physical activity via in school



where children and learning are One announcements, newsletters, posters, etc. The district is committed to providing these opportunities, and schools will ensure that these varied physical activity opportunities are in addition to, and not as a substitute for, physical education.



The district encourages the use of physical activity as a reward when feasible. Physical activity during the school day (including but not limited to recess, classroom physical activity breaks, or physical education) will not be withheld as punishment for any reason. This does not include participation on sports teams or with other sports-related after school activities, nor does it include participation on sports teams with specific academic requirements.

Physical education

The district will provide students with physical education using an age-appropriate, sequential physical education curriculum consistent with national and state standards for physical education. The physical education curriculum will promote the benefits of a physically active lifestyle and will help students develop skills to engage in lifelong healthy habits and incorporate essential health education concepts. The curriculum will support the essential components of physical education. See policy IHAE, Physical Education, for more information.

All students will be provided equal opportunity to participate in physical education classes. The district will make appropriate accommodations to allow for equitable participation for all students and will adapt physical education classes and equipment as necessary.

The district will integrate wellness activities across the entire school setting, not just in the cafeteria, other food and beverage venues, and physical activity facilities. The district will coordinate and integrate other initiatives related to physical activity, physical education, nutrition, and other wellness components so all efforts are complementary and work towards the same set of goals and objectives promoting student well-being, optimal development, and strong educational outcomes. Schools in the district will coordinate content across curricular areas that promote student health, such as teaching nutrition concepts in mathematics, with consultation provided by either the school or the district's curriculum specialists.

All efforts related to obtaining federal, state, or association recognition for efforts or grants/funding opportunities for healthy school environments will be coordinated with and complementary of the wellness policy including, but not limited to, ensuring the involvement of the district wellness committee.

All school-sponsored events will adhere to the wellness policy guidelines. All school-sponsored wellness events will include physical activity and healthy eating opportunities when appropriate.

Community partnerships

The district will develop and enhance relationships with community partners (e.g., hospitals, universities/colleges, local businesses, SNAP-Ed providers and coordinators) in support of this wellness policy's implementation. Existing and new community partnerships and sponsorships will be evaluated to ensure that they are consistent with the wellness policy and its goals.

Community health promotion and family engagement

The district will promote to parents/caregivers, families, and the general community the benefits of and approaches for healthy eating and physical activity throughout the school year. Families will be informed and invited to participate in school-sponsored activities and will receive information about health promotion efforts. The district will use electronic mechanisms (e.g., email or displaying notices on the district's website), as well as non-electronic mechanisms, (e.g., newsletters, presentations to parents or sending information home to parents), to ensure that all families are actively notified of opportunities to participate in school-sponsored activities and





Professional learning

The district follows the USDA Professional Standards for State and Local Nutrition Programs to ensure professional development in the area of food and nutrition is provided for all food service employees, including directors, managers, and staff.

When feasible, the district will offer annual professional learning opportunities and resources for non-food services staff to increase knowledge and skills about promoting healthy behaviors in the classroom and school (e.g., increasing the use of kinesthetic teaching approaches or incorporating nutrition lessons into math class). Professional learning will help district staff understand the connections between academics and health and the ways in which health and wellness are integrated into ongoing district reform or academic improvement plans/efforts.

District Wellness Committee/Coordinated District Health Advisory Council

The district will convene a wellness committee that meets at least once per year to establish district wellness goals for and to oversee school health and safety policies and programs including development, implementation, and periodic review and update of the wellness policy. Wellness committee members will include, to the extent possible, parents/legal guardians, students, representatives of district nutrition services, physical education teachers, school health professionals, the school board, school administrators, and the general public. The designated officer for ensuring district compliance with the wellness policy and oversight of the committee will be the Director of Food Service and Nutrition and may be contacted at 803-821-1170.

Annually, the district will notify the public about the content and implementation of the wellness policy and share any updates to the policy. The district will also publicize the name and contact information of the Director of Food Service and Nutrition with information on how the public can become involved with the wellness committee or obtain additional information on the wellness policy. The information for this annual review can be gathered through and utilized in the district's strategic planning process.

Every three years, the district will assess its compliance with the policy, how it compares to model wellness policies published by state and federal agencies, and the district's progress in attaining the goals of the policy. The results of this assessment will be made available to the public to showcase the wellness efforts being made by the district and how each school is in compliance with the wellness policy. Following this assessment, the district will update or modify the policy as necessary and share these changes with the public.

Recordkeeping

The district will retain records to document compliance with the requirements of the wellness policy. Documentation maintained by the district will include but will not be limited to:

- the written wellness policy
- documentation demonstrating that the policy has been made available to the public
- documentation of efforts to review and update the policy, including an indication of who is involved in the update and methods the district uses to make stakeholders aware of their ability to participate on the district wellness committee (e.g., copy of meeting notice posted on the district website)
- documentation to demonstrate compliance with the annual public notification requirements
- the most recent assessment on the implementation of the wellness policy
- documentation demonstrating the most recent assessment on the implementation of the

Food and Beverage Marketing

The district is committed to providing a school environment that ensures opportunities for all students to practice healthy eating and physical activity behaviors throughout the school day while minimizing commercial distractions. The district strives to teach students how to make informed choices about nutrition, health, and physical activity. These efforts will be weakened if students are subjected to advertising on district property that contains messages inconsistent with the health information the district is imparting through nutrition education and health promotion efforts. It is the intent of the district to protect and promote student's health by permitting advertising and marketing for only those foods and beverages that are permitted to be sold on the school campus, consistent with the district's wellness policy.

Any foods and beverages marketed or promoted to students on school campuses during the school day will meet or exceed the USDA Smart Snacks in School nutrition standards such that only those foods that comply with or exceed those nutrition standards are permitted to be marketed or promoted to students. These standards do not apply to marketing that occurs at events outside of school hours such as after school sporting events or any other events, including school fundraisers.

Contracts for goods or services that include a food and beverage marketing component executed after June 30, 2017, must conform to federal nutrition standards. No exceptions will be granted.

Food and beverage marketing is defined as advertising and other promotions in schools. Food and beverage marketing includes any oral, written, or graphic statements made for the purpose of promoting the sale of a food or beverage product made by the producer, manufacturer, seller, or any other entity with a commercial interest in the product. This term includes, but is not limited to the following:

- brand names, trademarks, logos, or tags, except when placed on a physically present food or beverage product or its container
- displays, such as on vending machine exteriors
- corporate brand, logo, name, or trademark on school equipment that is displayed during the school day, such as marquees, message boards, scoreboards, or backboards (<u>Note</u>: Immediate replacement of these items is not required; however, the district will replace or update scoreboards or other durable equipment when existing contracts are up for renewal or to the extent that is in financially possible over time so that items are in compliance with this policy.)
- corporate brand, logo, name, or trademark on cups used for beverage dispensing, menu boards, coolers, trash cans, and other food service equipment; as well as on posters, book covers, pupil assignment books, or school supplies displayed, distributed, offered, or sold by the district
- advertisements in school publications or school mailings
- free product samples, taste tests, or coupons of a product, or free samples displaying advertising of a product

Policy ADF School Wellness

Issued 4/06

Purpose: To establish the Lexington One school board's vision for providing a school environment that enhances the learning and development of lifelong wellness practices.

The school district is committed to a healthy school environment that offers children nutritious food choices, provides and promotes sequential and interdisciplinary nutrition education, and connects meaningful physical activity to students' lives outside of physical education. The healthy, physically active child is more likely to be academically successful. The school environment will therefore be safe, comfortable, pleasing and allow ample time and space for instruction, for eating meals and for physical activity.

The goal of this policy is to provide an environment that promotes health and wellness in the areas of nutrition and physical activity by doing the following contingent upon state funding.

- Through the district "nutrition education" programs, the students will gain an understanding of proper nutrition and nutrition practices.
- Through the district "physical activity" programs, the students will experience meaningful physical education and physical activity environments throughout the school day.
- Through other district "school-based activities", the students will be encouraged to engage in physical activity and healthy lifestyle formation.
- Through the district's "nutrition guidelines for food and beverages available during the school day", the students will be provided healthy, nutritional food selections throughout the school environment.

Schools in Lexington School District One are encouraged to take a positive approach to wellness, nutrition and physical activity that will impact students' health and the school environment. In all aspects of district wellness, the school staff will be encouraged to model good nutrition and physical activity behaviors.

Nutrition programs as well as physical education and activity programs will comply with the federal Child Nutrition and WIC Reauthorization Act of 2004 and with the South Carolina Student Health and Fitness Act of 2005.

The board provides the following guidelines to be used to establish and evaluate the district wellness programs according to the goals of the policy and will administer the wellness programs contingent upon funding from the state.

Nutrition Education

Nutrition education will be integrated into health education and into other areas of the curriculum.

The staff responsible for nutrition education will provide basic knowledge of nutrition combined with skill practice activities and will use instructional techniques and strategies designed to promote healthy eating habits.

Nutrition education will be incorporated during classroom instruction, snack times, and in the school dining area.

The school cafeteria will serve as a "learning laboratory" to allow students to apply critical thinking skills taught in the classroom in regards to the making of nutritional choices.

The school staff will not use foods of minimal nutritional value as a reward or punishment for students.

Students will be encouraged to start each day with a healthy breakfast.

Nutrition education will involve sharing information with families and the broader community to positively impact students and the health of the community.

Physical Activity

Physical education (PE) will be the environment where students learn, practice, and are assessed on developmentally appropriate motor skills, social skills, and knowledge.

Physical education will include the instruction of individual activities as well as competitive and noncompetitive team sports to encourage lifelong physical activity.

Students in grades K through eight will be provided the appropriate amount of physical education and physical activity as required by law and based on the SC Physical Education Curriculum Standards, including the appropriate student-to-PE teacher ratio.

Adequate equipment will be available for all students to participate in physical education.

Schools will administer the SC Physical Education Assessment in physical education classes in grades two, five, eight, and high school to assess PE standards and program effectiveness.

A report on an individual student's fitness status obtained from the SC Physical Education Assessment will be reported to his/her parent/legal guardian during the student's fifth, eighth, and high school physical education courses.

Physical activity will be integrated across curricula and throughout the school day as appropriate; movement can be made part of the core curricula.



A daily recess/physical activity time in elementary schools will be provided, which is not used as a punishment. Physical activity facilities on school grounds will be safe.

Information will be provided to families to help them incorporate physical activity into their children's lives.



Each elementary school will specify a physical education teacher as the physical education activity director to plan, coordinate and report on opportunities for additional physical activity for students to exceed the designated PE instruction time.

Other School-Based Activities

After-school programs will encourage physical activity and healthy habit information.

District wellness policy goals will be considered in planning all school-based activities, e.g. school events, field trips, dances, and assemblies.

Each school will organize wellness committees comprised of parents/legal guardians, teachers, administrators, and students to plan, implement, and improve nutrition and physical activity in the school environment.

Nutrition Standards and Guidelines

The child nutrition program will ensure that all students have affordable access to the varied and nutritious foods they need to stay healthy and learn well.

Foods and beverages made available on campus during school hours will comply with the current USDA Dietary Guidelines for Americans (including vending machines, á la carte foods, beverage contracts, school stores and canteens, and school-sponsored parties).

Schools will prohibit the sale of foods of minimal nutritional value. These are foods that provide little or no contribution to daily nutritional requirements. These include, but are not limited to, certain carbonated beverages, certain water ices, chewing gum, certain candies such as hard candy, jellies and some gummies, marshmallow candies, fondant, licorice, spun candy, and candy-coated popcorn.

A student may bring foods of minimal nutritional value or beverages from home for his/her personal consumption; however, the student may not sell these items to other students.

The district food services and nutrition division will maintain a list of foods appropriate for purchasing for vending machines and other sales the students will have access to during the school day (middle/high school).

Foods offered from vending machines or á la carte sales will contain no more than 35 percent, by weight, of sugar or other artificial sweeteners (middle/high school).

In elementary schools, students are prohibited from having access to vending machines.

Foods must be in compliance with the Institute of Medicine (IOM) recommended Nutrition Standards for Foods in Schools.

Student access to the sale and service of carbonated beverages will be prohibited.

Competitive Beverages

Acceptable beverages are as follows:

- plain water or seltzer water without added caloric sweeteners (with or without carbonation)
- 100 percent fruit or vegetable juice and 100 percent fruit or vegetable juice diluted with water (with or without carbonation) and no added caloric sweeteners
- beverages for high schools labeled as diet or light with less than 30 mgs of caffeine per serving (8 ounces)
- unflavored or flavored fluid milk and nutritionally equivalent nondairy beverages labeled as low-fat or fatfree
- elementary schools may sell up to 8-ounce portions; middle and high schools may sell up to 12-ounce portions of milk and juice; no portion size limit for plain water



The following beverages are not allowed:

- sport drinks which are not labeled as diet or light or exceed the 10 calories per 20 fluid ounces
- fruit-based drinks that contain less than 100 percent real fruit juice or that contain additional caloric



sweeteners

All beverage and food items must have nutrition specifications submitted to the student nutrition services department for review and final approval before being sold.

The district food services and nutrition division reserves the right to refuse service of any food or beverage item regardless of compliance of be policy guidelines and also reserves the right to limit quantities and exercise portion control on any food or beverage item offered at school.

Drinking water will be available for students at meals and throughout the day.

Classroom snacks in the elementary school will feature healthy choices that have at least minimum nutritional value and are not foods/beverages that are competitive with the school's operation of the national school breakfast or lunch program and/or after school snack program.

School cafeterias will offer a variety of age-appropriate healthy food and beverage selections for elementary, middle, and high schools.

Food and beverages sold at fundraisers will include healthy choices and provide age appropriate selections for elementary, middle, and high schools.

Advertising of foods or beverages in areas accessible to students during meal times must be consistent with established nutrition environment standards.

Elementary students will be provided at least 20 minutes to eat lunch and socialize once they have received their food.

Dining areas will be clean, attractive and have enough space for the seating of students.

Schools in Lexington School District One will use the School Health Index from the Center for Disease Control adapted for this policy to assess the strengths and shortcomings of the school's nutrition education, physical activity and other school based activity programs as well as the compliance with the nutrition standards and guidelines. Each school will use the results for the development of plans of action for improving student health and the school's environment. The district coordinated school health advisory committee will implement and monitor the district health policies and programs.
