



Dear Parent or Guardian,

The School Nutrition staff at each school invites and encourages your child's participation in the breakfast, lunch, and snack programs. Meals, foods and beverages sold or served at schools meet state and federal requirements based on the USDA Dietary Guidelines for students in the specified grade levels. All meals, foods and beverages are prepared and served by qualified child nutrition professionals. We provide students with access to a variety of affordable and appealing foods that meet the health and nutrition needs of students.

Meal Costs

Breakfast is at no cost for all students. Lunch is \$2.00 in elementary schools and \$2.35 in middle/high schools. The reduced cost of lunch is \$0.40. Meal costs for adults and/or visitors are: Breakfast \$2.20 and Lunch \$3.50.

We encourage parents to prepay a month or at least a week in advance by using myschoolbucks.com. This service allows the parent to use the internet to prepay for your child's school meals and a la carte food items using your credit or debit card. If paying manually, please place payment in a sealed envelope with your child's first and last name, homeroom teacher, and payment amount on the outside of the envelope. Include the student's first and last name on the check.

The My School Bucks site is easy to use, convenient, private and secure. Simply go to the www.myschoolbucks.com website or download the mobile application (App) to enroll and start using the site to deposit funds into your student's meal account. Once your account is established, you can check balances or fund the account anytime from your computer or phone. Your child's information is safe. Charging Meals

There is a "NO CHARGE" policy for high school students. Elementary and middle school students without cash or monies on their account will be allowed to accumulate charges in the amount of \$10.00. At that point the account must be paid before allowing additional charges. If a student has reached their charge limit an alternate nutritious meal will be provided.
