Paper applications will also be available at any school or at the Noblesville Educational Services Center. ### **Charge Policy**

The Nutrition and Food Services Department wants to ensure that every student has access to meals daily. We do recognize that there can be extenuating circumstances that may cause a student to not have money in their account, so procedures have been put into place to ensure students receive a courtesy light meal in these circumstances. **For more details visit us at: [millerscafe.org](http://millerscafe.org) and select charge policy.**

#### Elementary Level

Once an account reaches a negative balance equal to three meal charges (-\$6.00/paid or -\$1.20/reduced) the student will be offered a light breakfast and/or a light lunch at no charge.

#### Middle School Level

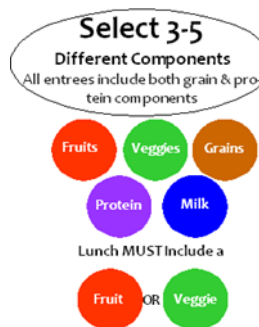
Once an account reaches a negative balance equal to two meal charges (-\$4.50/paid or -\$0.80/reduced) the student will be offered a light breakfast and/or a light lunch at no charge.

#### High School level

If a student does not have funds in their account or cash in hand, the student will be offered a light breakfast and/or a light lunch at no charge.
