Pre-Conference Class Email from Tamra:

Hey Guys,

As we visited on the phone, I will be putting on a culinary training for the Farm to School grant in June. I recently hosted the same Culinary Training and it was wildly successful. Because it is all hands-on and the participants are actually cooking and learning new knife and other prep skills, they are engaged all the time.

The training is put on by ICN and is called Healthy Cuisine for Kids. It is two days of 8 hours each day. The cost-minimal. As hosting as part of the Farm to School grant, it would not cost SNA anything.

So the thought would be to combined the Farm to School Healthy Cuisine for Kids training into SNA. The thought is to have the 1st 8-hour day as the "pre-conference" workshop on Monday and then break the second 8 hours into two, 4 hour sections on Tuesday and Wednesday (either morning or afternoon). In that manner, SNA opening ceremonies and other break out sessions could take place both days.

Although most of the other ICN trainings that are offered are at least 4 hours long, I think it might be possible to work with ICN since we will already have a chef and a dietician there to conduct a one-hour breakout session on both Tuesday and Wednesday.

I am going to contact ICN to see if they might be interested in doing this. A couple of the trainings I think they may be able to cut down to one hour for break out sessions are: 1. Utilizing the Cafeteria as a Classroom, 2. You are a Team, 3. Forecasting Procurement of Foods and Mock Health Inspection.

The thought behind combining the events is that everyone will already be in one spot. I have had issues getting people to attend workshops even though I provide travel aid. Hopefully, since we already have a large audience coming to one spot, it would increase the workshop attendance but also benefit SNA because it is all hands-on and cost effective.

Tamra, Gina and I visited about this and I will contact ICN to see if they would be amenable to the suggestion, but we wanted to present the idea to the SNA board to see if there is interest in doing something along these lines!
