Child Nutrition Program – PUBLIC NOTICE

Zapata County ISD will continue its policy to operate the Community Eligibility Program (CEP) under the National School Lunch and Breakfast program for the 2018-2019 school year. The following ZCISD schools will participate in the Community Eligibility Provision program for the 2018-19 school year; Zapata High School, Zapata Middle School, A.L. Benavides Elementary, Zapata North Elementary, Zapata South Elementary, and Fidel & Andrea Villarreal. Schools qualifying to operate CEP serve breakfast and lunch to all children at no charge and eliminate the collection of meal applications for free, reduced-price, and paid student meals. This new approach reduces the burdens for both families and school administrators and helps ensure that students receive nutritious meals.

After School Snacks will be provided to students participating in eligible after school programs, which include educational and enrichment activities in an organized, structured, and supervised environment.

Zapata County ISD will participate in Child and Adult Care Food Program (CACFP) for the 2018-2019 school year. This program will provide supper meals to students on campuses that provide educational and enrichment activities in an organized, structured, and supervised environment.
