Reimbursable BREAKFAST AND LUNCH MEALS WILL BE SERVED TO ALL STUDENTS AT **NO COST TO THE PARENT!** No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit a meal application.

Each and every student at HIGHLAND VIEW ELEMENTARY, STONEWALL JACKSON ELEMENTARY, VAN PELT ELEMENTARY, WASHINGTON LEE ELEMENTARY, VIRGINIA MIDDLE SCHOOL and VIRGINIA HIGH SCHOOL will be eligible to receive a breakfast and lunch meal at **NO COST** each and every day!

Students will enter their PIN numbers at the end of the meal line and receive their meal at no cost. **If your student wishes to purchase ala carte items such as bottled water, 100% juice, ice cream, etc. you will need to provide money for those purchases.** Many studies have shown that a hungry child cannot learn so please encourage your child to participate by choosing a nutritious reimbursable breakfast and lunch meal each and every day at NO COST TO YOU.
