



Frequently Asked Questions about Summer P-EBT

1. How do I know if I qualify for Summer P-EBT?

If you qualify for free and reduced-price school meals in school year 2020-2021, you will be eligible for Summer P-EBT.

2. When will benefits be issued?

Benefits will be issued in a one-time payment on August 25, 2021. Benefits will be loaded on your existing EBT card.

3. How much will students/children receive for the summer benefit?

Students will receive benefits of \$375 per student to cover the summer period.

4. What if I just completed my application for free and reduced meals at my school?

If you applied after June 30, 2021 and before July 31, 2021, you will receive benefits on August 25, 2021.

5. What if I have a child that is under six years of age? Will they also receive Summer P-EBT benefits?

Yes, children under the age of six are also eligible for the Summer P-EBT benefit. In order to receive the benefit, these children must be enrolled in the SNAP program during the summer months. The benefit will be the same amount of \$375 per child and issued on August 25, 2021.

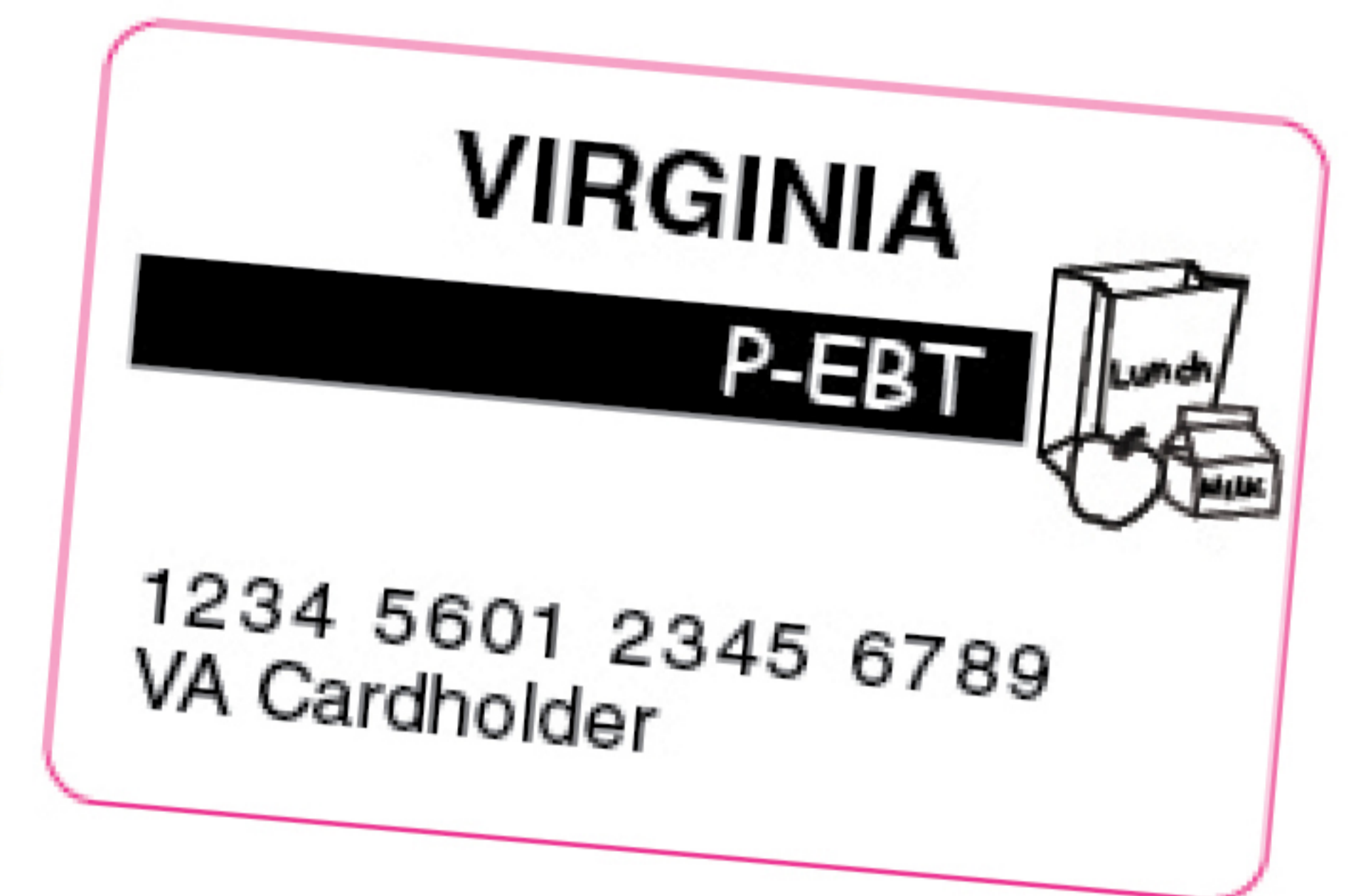




NEW TO P-EBT?

The Pandemic Electronic Benefit Transfer (P-EBT) program is a federal program originally created to supplement school meals that students missed while schools were closed. The P-EBT program does not affect your ability to receive other benefits and can be used to buy SNAP-eligible food. The money on your card will carry over from month to month and expire after a year.

P-EBT BENEFITS FOR SUMMER 2021

All children who qualified for free or reduced-price meals, regardless of learning method (fully remote, hybrid or in-person), **during the 2020-2021 school year will receive a one-time, lump sum benefit of \$375 on August 25, 2021.**

This benefit is intended to cover the summer months when schools are closed and students don't have access to school-provided meals.
